Who Will Be Affected? Residents of Sunland, Tujunga, La Tuna Canyon, Shadow Hills, Sun Valley, Lake View Terrace and Crescenta Valley, travelers on the 210 Fwy and La Tuna Canyon Rd, & recreational users of the Verdugo Mountains.
